# 2018 Parade of Homes

## St. James Directions

- 19 3859 Fairhaven Drive**  
Enter St. James Plantation, continue on St. James Drive. Turn right into the Reserve onto Ridge Crest Drive, turn right onto Marshfield, turn right onto Fairhaven Drive and home will be on the right.
- 20 3778 Ridge Crest Drive**  
Return on Fairhaven Drive to Marshfield, turn left onto Marshfield, turn right onto Ridge Crest Drive (almost to the end) and home will be on the right.
- 21 3943 Wyndmere Drive**  
Continue on Ridge Crest Drive to stop sign, turn right onto Wyndmere Drive and home will be on the right.
- 22 3736 Bridgewater Drive**  
Go back on Wyndmere Drive towards Ridge Crest Drive, continue past Ridge Crest Drive, turn right onto Bridgewater Drive and home will be on the right.
- 23 3732 Wynston Court**  
Continue on Bridgewater Drive, turn left onto Essex Drive; near the end of Essex Drive stay left, turn left at stop sign onto Moss Hammock Wynd, turn left onto Wynston Court and home will be on the left.
- 24 3287 Moss Hammock Wynd**  
Return on Wynston Court back to Moss Hammock Wynd, turn right onto Moss Hammock Wynd past Essex Drive and home will be on the right about .8 miles.
- 25 3529 Wellington Place**  
Continue on Moss Hammock Wynd, turn right onto Wellington Place and home will be on the right.
- 26 3682 Holly Harbor Drive**  
Return on Wellington Place to Moss Hammock Wynd, turn right onto Moss Hammock Wynd to the end, turn left onto Oceanic Drive, at round-about take the second exit onto Pine Forest Drive, at round-about take the first exit onto Parkridge Drive, turn right after the bridge onto Holly Harbor Drive and home will be at the end of the cul-de-sac.
- 27 2571 Shellbark Court**  
Return on Holly Harbor Drive back to Parkridge Drive, turn right onto Parkridge Drive, turn right onto Pepperbush Drive, turn left onto Shellbark Court, and home will be on the right.

- 28 2775 Long Bay Drive**  
Return on Shellbark back to Pepperbush Drive, turn right, turn left onto Parkridge Drive, continue over the bridge and to the round-about, take the first exit right onto Morningdale Drive, turn left onto Wingfoot, take a slight right onto Fairway Village Drive, turn left onto Members Club Blvd. to the stop sign. Turn right onto St. James Drive, continue pass the clubhouse on left and over the bridge, continue to the round-about; take the first exit onto St. James Drive, turn left onto Long Bay Drive, keep right to stay on Long Bay Drive and home will be on the left.
- 29 2488 St. James Drive**  
Return on Long Bay Drive back to St. James Drive and turn left and home will be on the right.
- 30 3822 Grand Willow Circle**  
Continue on St. James Drive approximately 1.2 miles, turn right onto Grand Willow Circle, and home will be on the right.

### To Exit St. James Plantation:

Continue on Grand Willow Circle, turn right onto St. James Drive, proceed to the exit gate which takes you onto Maxwell Drive. A right at the stop sign goes toward route 211; a left goes to Oak Island.

## Brunswick Forest Directions

- 10 5525 Mt. Pleasant Circle**  
From 17 North turn right into Brunswick Forest and continue on Brunswick Forest Parkway, take 2nd left onto Low Country Blvd, turn left onto Mr. Pleasant Circle and home is on the right in circle
- 9 5033 Creswell Drive**  
Take Mt. Pleasant Circle back to Low Country Blvd., turn right onto Cape Fear National Drive, turn left onto Creswell Drive and home is on the left
- 8 2110 Colony Pines Drive**  
Continue on Creswell Drive, turn left onto Colony Pines Drive and home is on the right.
- 11 1348 Cross Water Blvd.**  
From Colony Pines Drive turn left onto Cape Fear National Drive, turn right onto Low Country Blvd, turn right onto Cross Water Circle and home is on the right.
